- Results for the Cook County Assessor appeals should be finalized in January and decision letters mailed at that time. The last opportunity to appeal in this triennial will be with the Board of Review in 2022.
- Tax bills are available online on the Treasurer's website and will be mailed to property owners in early February, 2022.
- The deadline for 2021 permits will likely be mid-December. We are caught up and processing November as the Villages send them. The entire Permit system has transitioned from a paper to an electronic system this year. Villages email the permits in an electronic format that we can input, code, check the accuracy of square footage and description of the work done and then submit to the County through their new system. There are still many technical issues to be resolved before the process goes smoothly. Very few paper copies of permits are now handled by our office.
- We have begun to replace Sidwell maps with the updated pages that have revisions such as new Property Index Numbers, divisions, and corrections.
