## **OFFICIALS' REPORT**

**ASSESSOR:** Assessor Jochum reported:

- TAX YEAR 2022
- The Cook County Board of Review has completed the review of Wheeling
  Township and appellants are being notified. At this point I do not have total
  results available for our Township, but they should be available in the next few
  days. We are currently fielding calls regarding appeal results.
- TAX YEAR 2023
- We anticipate that we should be open for appeals with the Cook County
   Assessor within the next few weeks. We are currently taking pre-filings so that
   we can stay ahead of the crush of appeals during the thirty-day period.
- Even though this is the second year of the reassessment, we encourage property owners to appeal, there is no cost and it may result in savings.
- EXEMPTIONS
- The filing for exemptions for tax year 2022 will conclude the first week of August.
   Consequently, we encourage taxpayers to call our office if they think they are qualified for an exemption.
- The February to July exemptions requests are as follows:
- SENIOR EXEMPTIONS 382
- SENIOR FREEZE 1059
- HOMEOWNERS 166
- DISABLED PERSONS 114
- DISABLED VETERANS 50

- TOTAL TAXPAYER EXEMPTIONS FILED 1771
- We estimate a minimum first year savings for Wheeling Township Taxpayers of \$1,530,600.

- This year our office has reviewed and processed 1,495 permits for a total permit amount of \$79,381,460.
