## **OFFICIALS' REPORT**

**ASSESSOR:** Assessor Jochum reported:

- TAX BILLS
- A Board of Review representative has informed us that the second installment of the (2021) tax bills will likely be mailed in December. As a result, taxpayers will pay in January. Then taxpayers, after paying the second installment of the (2021) taxes will immediately receive a bill for the February 1<sup>st</sup> installment of the (2022) tax bill to be paid by March 2023. In addition to hardship for taxpayers, this could cause a significant funding issue for some taxing bodies.
- APPEALS AND ASSESSMENTS
- There is still no word about when the County Assessor will complete the Wheeling Township assessment hence no information on appeals availability.
- However, the County Assessor's office has informed us that next year's reassessment for the Northern Tri will likely be up 24%-36%. They apparently know this about 2022 taxes before completing the 2021 tax year.
- With upcoming primary election in June, there may be considerable turmoil in both the Cook County Assessor's office and the Board of Review. This may affect the Township's outreach activities with Cook County. Consequently, we are looking into the Township conducting its own outreach events to taxpayers.
- Our performance review for tax year 2019 (Last Tri) is complete. The Wheeling Township Assessor's staff helped Wheeling taxpayers avoid overpayment in

excess of \$2.8 million dollars. Case success rate was 65%. We should be proud of our excellent staff and their continuing service to our residents.

- EXEMPTIONS: This key form was finally approved and exemptions for Wheeling Township have been filed.
- NEW WHEELING TOWNSHIP HOMEOWNERS: We have begun the process of mailing information packets to new homeowners informing them of the Township Assessor resources.
- OTHER ACTIVITY: Cook County Treasurer Maria Pappas has agreed to cosponsor a seminar with officials from Wheeling Township to review her study regarding the impact of debt on property taxes. The initial meeting will focus on municipalities and school boards. Details are being worked on and more information will be provided when available.

# OLD BUSINESS:

# 2022-23 AGENCY FUNDING DISCUSSION:

Catholic Charities decided not to apply for funding and was not included in the Agency funding. Escorted Transportation funding was kept the same. Faith Community Homes was reduced to \$10,000. Hands on Suburban Chicago was reduced to \$2000. Journeys funding was kept the same. Kindred Life Ministry funding was kept the same. Life Span funding was kept the same. The Mobile Dental Clinic funding was kept at \$35,000. Northwest Compass funding was increased from \$29,000 to \$31,500. Resources for Community Living funding was kept the same. St. Mary had a slight increase of \$1000. Access to Care funding was raised to \$18,000 because it is used a lot. No new agencies were added for funding.

Alexian Brothers funding will increase to \$100,000 to help meet mental health needs. The township will also contact Northwest Community Behavioral Health to consider if can work with them. Avenues to Independence funding was increased \$2,000. Center for Enriched Living funding was increased \$1,000. Clearbrook funding was kept the same. Countryside funding was kept the same. The Jocelynn Center needs to assist AMITA and funding was increased to \$22,000. Those are only changes. In total, the agency budget increased less than \$5,000.
