## **OFFICIALS' REPORT**

**ASSESSOR:** Assessor Sadler reported:

- Wheeling Township opened for appeals July 8<sup>th</sup>, and closed August 8<sup>th</sup>, 2019. The number of appeals was an all-time high, a total of 2,202.
  - 1,291 Hard Copies
  - 671 emails (these continue to increase every year)
  - 240 comparables given to constituents who took home to mail or appeal online
- Decision letters should be mailed in October.
- Second Installment Tax Bills were mailed July 1<sup>st</sup>. The error on the Senior Freeze Exemption affected at least 5,000 taxpayers in Wheeling Township.
- This miscalculation resulted in 880 extremely concerned Seniors who came into the Assessor's Office for questions and resolutions to the problem, as well as 47 emails. Less than half of the tax bills were automatically corrected by the County. The Assessor's Office emailed the County daily corrections to be made and a new revised bill to be sent (a total of 467). The Seniors were grateful the Assessor's Office could assist them with an adjusted lower bill before the deadline. Seniors continue to come in with incorrect adjusted bills.
- This issue, which coincided with Appeals, was unprecedented and a situation our office was not staffed to handle. The employees put forth their best effort-many compliments and letters of gratitude were received.
- Total number of office visits from first of July through end of appeals was 3,630.

#### **ADMINISTRATOR'S REPORT:** Administrator Stapleton reported:

 The businesses and residents were as usual very generous with back to school donations. Ready 4 Success distributed about 200 backpacks to children heading back to school. We also prepared boxes of school supplies for Buffalo Grove High School, Wheeling High School, D21 and D23 to distribute to children in need.

- The Board is registered for the TOI Conference, please let me know if your plans change and are unable to attend by October 7<sup>th</sup>.
- After some discussion, we have decided to look for a temporary person to fill the vacant GA Caseworker position for September 1 through December 31st. Julie Villarreal and I will be interviewing 4 candidates this week. In January we will start looking for a full-time GA Caseworker.
