## **ASSESSOR:** Assessor Sadler reported:

- Wheeling Township is scheduled to receive reassessment notices July 5. The majority of the phone calls and office visits are questions pertaining to an appeal.
- Assessor's Office expects a high volume of phone calls and office visitors and this coincides with the receipt of the tax bill.
- The Second Installment tax bills are available on the Treasurer website. All taxpayers will receive their bill in the mail July 1<sup>st</sup>. The County made an error on the calculation of the Senior Freeze on some bills. Many seniors have called Assessor's Office regarding this issue. Julia Lipka spoke with Cook County Assessor's Office and these bills will be adjusted and a correct tax bill will be issued before the due date.
