## **OFFICIALS' REPORT**

**ASSESSOR:** Assessor Sadler reported:

- EXEMPTIONS
- The online process to file 2020 exemptions is now closed; all exemptions are Certificates of Error's which will result in a revised tax bill or a refund.
- COOK COUNTY TREASURER
- The Treasurer's latest information is that the 2020 Second installment tax bills are tentatively scheduled to be mailed at the end of August with a due date of October 1<sup>st</sup>. The bills will be available on the Treasurer's website mid-August. The volume of calls and in person visits have increased as taxpayers' question when they will receive the tax bill.
- COOK COUNTY ASSESSOR
- Based on the current schedule, Wheeling Township should be open for appeals in September. In the meantime, constituents can email our office to request comparables which we will send along with instructions for filing an online appeal. If they don't have access to a computer they can complete an appeal form and we will enter the appeal when the Township is open for appeals. This is the 3<sup>rd</sup> year of the Triennial. Next year the Township will be reassessed.

# **ADMINISTRATOR'S REPORT:** Administrator Stapleton reported:

- Benchmark Developers is purchasing four lots on Scottsvale Road, the street behind the cemetery. They would like to put a fence on our property. Administrator Stapleton has spoken with the Cemetery Trustees regarding this, and they agreed with putting the fence up.
- On July 23<sup>rd</sup>, Supervisor Penner and Administrator Stapleton met with Pastor Wetherell from the Orchard of Arlington Heights. They discussed how the Township and the church can partner together on helping people in need. Julie Villarreal and Craig Wleklinski gave him a tour of the Food Pantry.
- General Assistance is seeing an increase in requests for Emergency Assistance due to the eviction moratorium being lifted as July 1<sup>st</sup>.
- We have hired a new Auxiliary Caseworker in General Assistance, Gabriela Aguilera; she will start July 28<sup>th</sup>.
- Statistics for June 2021:
  - 1,212 rides-377 non-medical, 835 medical
  - 1,300 meals delivered
  - 245 visits to the Food Pantry-459 people fed

# NEW BUSINESS:

Administrator Stapleton- Bob Passi was hired as a part-time driver at WT. He starts Pace training on Monday and passed all other requirements. The starting salary is \$16 per hour.

**Audit by Judy Walther-** Wheeling Township received an unmodified opinion or clean opinion from the outside auditor. The Township financials complied with all Generally Accepted Accounting Standards. IMRF pension funds available for pension obligations decreased some \$400,000. During the last fiscal year because of COVID-19, the Township received about \$350,000 for the emergency fund compared to previously receiving about \$50,000 per year in donations. Social Services costs rose some \$100,000 due to COVID assistance efforts. Overall, the Township remains strong financially.
