ASSESSOR: Assessor Sadler reported:

- Assessor's Office continues to assist Taxpayers with 2018 Exemptions. This
 month it was primarily Disabled Veterans and Disabled Persons who received
 their renewals. Seniors who have not completed their renewals continue to
 come in for aid with their forms. Assessor's Office was told that the
 newsletter was a helpful reminder. All exemptions are due April 1, 2019 to be
 deducted from the July tax bill.
- Taxpayers who appealed with the Board of Review in December should receive decision letters in March, later than expected due to the high volume received by the Board.
- Permits are starting to pick up again as Villages tend to issue fewer in winter months.

CLERK'S REPORT: Clerk Gauza reported:

- We received a letter from the Cook County Department of Revenue stating that starting in May 2019, all the Townships will no longer be accepting vehicle sticker payments anymore. Payments will be accepted online, by mail, in person at DOR or bought at different Currency Exchange locations.
- DOR will be implementing a new STICKER-LESS Wheel Tax process for the 2019/2020 Wheel Tax Season. When someone pays, they will no longer be given a physical vehicle sticker to put on their windshield. Stickers are going away, and the Townships will no longer be involved with vehicle stickers anymore.

ADMINISTRATOR'S REPORT: Administrator Stapleton reported:

- Update on 3215 North Salk. The judge ordered the demolition of the building. There will be a hearing next week to see if the homeowner contests the demolition and if not, then the court will proceed to have bids for the demolition.
