OFFICIALS' REPORT

ASSESSOR: Assessor Sadler reported:

- EXEMPTIONS
- The deadline to file online exemptions was extended to April 19th. The online process is now closed; however, we can email the applications through our usual procedures to the County until we are notified of a cutoff date. This will ensure the exemption is on the 2nd installment tax bill. We entered about 150 exemptions through DocuSign for taxpayers who don't have access to a computer or had difficulty with the electronic application.
- Most 2020 exemptions automatically renewed, including the Senior Freeze, Persons with Disabilities and Veterans with Disabilities. The regular Senior began an automatic renewal last year. The County made this decision to minimize COVID exposure to seniors and those with disabilities. This autorenewal is only for this year. 2021 tax year will require a renewal.

COOK COUNTY TREASURER

- 2020 first installment tax bills were mailed February 1^{st.} and due by May 3rd with no penalty. There is a possibility the 2nd installment bill may be delayed a month; this has not been confirmed.
