

- INR & PRO Time Anticoagulation Therapy Testing (\$6 charge)

### Cholesterol Screening:

2nd & 4th Thursday of Each Month • 9:00 a.m. - 11:30 a.m. (Available to residents 18 years & older)

Eight hour fasting (water only) lipid profile including total cholesterol, HDL, LDL, triglycerides and blood sugar (\$15.00 charge) Cholesterol screenings require drawing of a blood sample from the fingertip. At-home hemoccult screening tests available for \$4.00

This year, the Township nurse will have a limited supply of the flu shots for homebound patients over the age of eighteen, who are unable to get a flu shot from their physician. Please call Karen McNeir, R.N., B.S.N. to schedule a home visit. The flu shot is covered by Medicare Part B. If you do not have Medicare, the cost is \$25.00



## **ENERGY ASSISTANCE PROGRAMS** Now Taking Applications





DVP, or Direct Vendor Payment, is designed to assist income-eligible households with energy services, in the form of a one-time benefit payment to the utility companies that is applied directly to the household's energy bills. The amount of the payment is determined by income, household size, and fuel type. Reconnection Assistance is used to prevent or reconnect disconnected households.

PIPP, or Percentage of Income Payment Plan, provides a monthly benefit payment to the utilities based on household utility usage and monthly income. The qualifying accounts are enrolled in utility budget billing and customers are required to pay a reduced amount on their utility bills each month to get the benefit payments. PIPP participants who make their utility payments on time will receive credits towards their outstanding balance. Disconnected households are not eligible.

Furnace Assistance is designed to restore the home's heating system back to a safe and effective operation. Assistance is only available to approved households that have or are eligible to receive a LIHEAP benefit and whose heating systems are not operational or have been red-tagged by their utility company. The services are free of charge for income qualifying households. Renters are not eligible to apply.

# From the Clerk – Joanna Gauza VOTER REGISTRATION

The General Election on November 8, 2016 for President, Congress, many Illinois State Legislative seats, and local offices promises a large voter turnout. If you want to vote in the General Election, now is time to make sure you are registered. If you are not registered, have just moved into the Township, have moved to another residence in the Township, or changed your name, you need to register to be able to vote in these and future elections. To register, come to the Clerk's Office, Monday-Friday, between 9:00-4:30. All you need are two forms of identification (one showing your current address), be a citizen of the United States, be 18 years of age or older by the November 8 election, and live in the Township for at least 30 days before the election. For naturalized citizens, you must prove the date of your naturalization. If you have an Illinois driver's license or state ID, you may register online through the Illinois State Board of Elections website **elections.il.gov.** If you don't have a driver's license or state ID, go to **cookcountyclerk.com** and complete the form online, print, sign and mail it to the address on the application. If you register by mail, you must bring a valid state issued picture identification when you vote for the first time.

### **Early Voting**

For the November 8, 2016 Presidential Election, traditional Early Voting will take place **October 24-November 7**. The Arlington Heights Village Hall, 33 S. Arlington Heights Road, will be an early voting location. Starting October 24 through October 29, the Village polling station will be open 9:00 am to 5:00 pm. On October 30, the Village polling station will be open 9:00 am to 3:00 pm and from October 31 to November 4 and November 7, the polling station will be open 9:00 am to 7:00 pm. On November 5 the station closes at 5 pm and November 6 at 3pm. Voters do not need to provide an excuse or reason why they cannot vote on Election Day. **Government-issued photo ID is not required** but is helpful if there is a question about the voter's registration, address or signature. Providing an ID can also speed up the process because we have ID card readers at every check-in station.

### Mail Ballots

Any registered suburban Cook County voter may request a mail ballot using this online application at https://mailvoting.cookcountyclerk.com. Once Cook County verifies your registration and processes your application, Cook County will send a paper ballot to the mailing address you designate on your application. The deadline to apply is

five days before an election. If you do not have one of the online application requirements, or if you prefer to apply on paper, you may download, print and sign a mail ballot application and send it to the Cook County Clerk's office. You can also get a mail ballot application at our Clerk's office.

### **Election Judge Jobs**

Earn \$175 as an Election Judge or \$325 as an Equipment Judge. Do good and earn money on Election Day by working the polls. You must be a U.S. citizen registered to vote in Cook County or a High School student with at least a 3.0 GPA. The duties include completing online and hands-on training classes, helping set up the polling place with your fellow judges, and working Election Day from 5 a.m. until the results are transmitted and the equipment has been packed up at the end of the night. You can apply and learn more at Cook County Board of Elections http://www.cookcounty clerk.com/elections/electionjudges/Pages/default.aspx. # From the Assessor – Jerry Sadler COOK COUNTY BOARD OF REVIEW

2016 Wheeling Township property assessments can still be appealed with the Cook County Board of Review. The Board sets a 30-day appeal window annually for each Township in Cook County posted on their website at www.cookcountyboardofreview.com. Using the property index number, homeowners can file a complaint online prior to or during the 30-day appeal window. Appeals can also be made with an official Board of Review appeal form. The forms are available online, at all Board of Review locations or from our office. The Board of Review maintains a branch office in the Rolling Meadows Circuit Courthouse building to serve the northwest suburban taxpayers of Cook County. It is located at 2121 E. Euclid Avenue, Room 237, Rolling Meadows, Illinois 60098; and the phone is 874-818-2067. An appellant has the option to request a hearing with the Board, but does not need to do so in order to have the appeal reviewed. If you are successful in getting a reduction in your assessed value, it will be reflected on your 2016 second installment property tax bill payable in 2017.

We are available to provide information and direction on filing an appeal. Please have your property index number available when you visit or call our office at 847-259-1515. Once the appeal period opens for Wheeling Township, you may email us for comparables at: taxpayerassistance@wheelingtownship.com. It is best to wait until we are open for appeals to request comparables, so that the assessed values are current.

### DISABLED VETERANS EXEMPTIONS CHANGES

Senate Bill 107 (Public Act 99-0375) amends the Property Tax Code for the disabled veteran's standard homestead exemption for taxable years 2015 and thereafter as follows:

- Veterans with 30%-49% **service-connected disability** receive \$2,500 annual exemption.
- Veterans with 50%-69% **service-connected disability** receive \$5,000 annual exemption.
- Veterans with 70% or **more service-connected disability** are completely exempt from property taxation on their primary residence.

The exemption amount (along with any other exemptions such as the standard homeowners or senior exemption) is deducted from the Equalized Assessed Value (EAV) which is then applied to the tax rate to determine a taxpayer's bill. The exemption will be deducted from the 2016 2nd Installment property tax bill. Forms will be available sometime in January 2017 from the Cook County Assessor's Office and online at **www.cookcountyassessor.com**. If you received the exemption last year, you should receive a renewal form that you will need to complete and return to the county after the new year.

Seniors who filed a **Senior Exemption** for 2015, should also receive a renewal form. *All Seniors need to complete the senior portion and return* **even if you do not qualify for the Senior Freeze.** The renewal exemption forms and property tax bills do not get forwarded to a winter address. You will need to get the form online or through our office. If you do not send in the original renewal form, you will need to attach a copy of a tax bill and your driver's license or state I.D. If you do not receive the property tax bill, which the Cook County Treasurer mails in February, and is due at the beginning of March, you may pay online at the treasurer's site which is: **www.cookcountytreasurer.com**.

## From the Highway Commissioner - Scott Saewert

### **WORKING FOR YOU 2001—2016...**

I have served as the Wheeling Township Highway Commissioner since 2001. The Highway Commissioner is mandated by the State to maintain unincorporated roads within Wheeling Township. Many of the unincorporated areas have previously been annexed by neighboring villages; the remaining 5.4 miles of unincorporated roads have historically had problems with drainage and experience storm water flooding. When the Township Road District makes drainage improvements in these areas, it improves the conveyance of the upstream storm water from surrounding villages that drain through these areas and the villages within Wheeling Township benefit from these improvements. Well maintained roads are not just a local improvement but also benefit all motorists traveling through the unincorporated areas.

The Road District works to keep levies low and minimize the cost to Township taxpayers. Half of the Wheeling Township Road District annual tax levy is distributed to the surrounding villages for their road maintenance needs and the remaining funds are used for projects that can be completed each year, plus normal maintenance, administrative costs and contingencies.

During the last fifteen years, the Wheeling Township Road District has completed 38 major road projects, including 22 road drainage ditch restoration projects and 16 road resurfacing projects in the unincorporated areas. With financial assistance from state grants, Wheeling Township purchased a flood prone house in the Forest River Subdivision. This allowed restoration of the Feehanville drainage channel from upstream subdivisions to the Des Plaines River and provide a storm water management area. The Road District reconstructed and raised the most flood prone road and brought it out of the flood plain to provide further flood protection to local residents. Buyout discussions with Cook County continue for flood-prone properties in the Forest River Subdivision.
