TRANSPORTATION SERVICES...

More Than Just a Ride!

Unable to drive? Looking for safe and affordable transportation? If you are age 60 and over or age 18 and over with a permanent disability, the Wheeling Township Transportation services may be an answer for your transportation needs. In 2014, over 24,500 rides were provided to our residents. Service hours are 9:00 a.m. to 3:30 p.m. Monday through Friday within the Wheeling Township boundaries.



For those needing to travel outside Wheeling Township boundaries for medical appointments, TRIP may be the answer. This long standing collaboration between PACE, and Elk Grove, Hanover, Palatine, Schaumburg, and Wheeling Townships, uses State grants to subsidize riders fares. The one-way cost is \$5.00 for every township line crossed during a single trip, not to exceed \$10.00. TRIP's service hours are Mon. thru Fri. 5AM-9PM & Sat. 7AM-4PM. Destinations include VA medical facilities in Maywood, Elgin, & North Chicago and Stroger Hospital, Rush University Hospital, University of Illinois Hospitals, Loyola Medical Center, Northwestern Memorial Hospital, Good Shepard Hospital, ARA So. Barrington Dialysis Center and specified Social Security Offices. Call our Transportation Department at 847-259-7743 for program services and eligibility.

(Available to residents 18 years & older)


Eight hour fasting (water only) lipid profile including total cholesterol, HDL, LDL, triglycerides and blood sugar (\$15.00 charge) Cholesterol screenings require drawing of a blood sample from the fingertip.

At-home hemocult screening tests available for \$4.00

Concerned About the flu? What to do?

This year, the Township nurse will have a limited supply of the flu shots for homebound patients over the age of eighteen, who are unable to get a flu shot from their physician. Please call **Karen McNeir, R.N., B.S.N.** to schedule a home visit. **The flu shot is covered by Medicare Part B.**

If you do not have Medicare coverage, the cost is \$25.00



ALZHEIMER'S CAREGIVER SUPPORT GROUP

It is estimated that as many as 5.1 million Americans may have Alzheimer's disease. The incidence of the disease is rising with the aging of America. Providing care for someone with memory loss can be a labor of love, but it can also be exhausting and stressful.

Wheeling Township partners with the Alzheimer's Association – Greater Illinois Chapter to offer a monthly support group for caregivers of individuals with Alzheimer's disease. The support group is designed to provide emotional, educational and social support for caregivers through monthly scheduled meetings.

Karen McNeir, R.N., B.S.N. and Kris Freeman, M.A. co-facilitate this group, offering help to participants in developing coping methods and encouraging caregivers to maintain their personal, physical and emotional health, as well as providing optimal care for the person with dementia.




STOP IN TO IMPROVE YOUR DRIVING SKILLS...

MAKING THE PANTRY PERSONAL

Do you ever wonder what makes the Wheeling Township Food Pantry so successful? Although most published information is on the statistical data of the recipients, here is a glimpse into what actually makes the cogs of the pantry machine work: Donors and Voluntary Crew Members.

Lorelle Silverman has been growing and donating fresh produce to the Wheeling Township Food Pantry for the last three years. Originally she began working the garden at the Clerics of St. Viator in Arlington Heights and now Lorelle has expanded her efforts with a 400 square foot garden at her home.

Lorelle sites her commitment as a way to honor her mother's memory. During the Depression, her mother was separated from her family and they were often hungry. Once she got through the hard times, she always made it a point to donate to local food pantries. Lorelle remembers her mother often saying "hunger happens every day" and having a special worry for children who go without.

Lorelle continues the tradition of donating that her mother began and has combined it with her love of gardening. In addition to all of the gardening for the food pantry, Lorelle also volunteers at the Chicago Botanical Gardens weekly. Lorelle has found a wonderful way to combine her love for getting her hands dirty with helping others in our community!

Barbara Stoga is one of the 44 member Wheeling Township Food Pantry Crew who make the pantry work on a day to day basis. Crew members sort and shelve donated food as well as assist recipients directly by answering questions, "cashiering" and providing bagging services.

Barb Stoga has volunteered in the Wheeling Township Food Pantry since November of 2008. Her dedication and commitment earned her the Volunteer of the Year Award in 2014. Barb has continued her efforts and in May of this year she was recognized by Hands On Suburban Chicago's RSVP program with the winning of The Presidential Volunteer Service Award.

The Presidential Volunteer Service Award is given locally, regionally and nationally to those who have committed more than 100 hours of their time in a year to a worthy cause. Its purpose is "to encourage a sustained commitment to civic participation, and inspire others to make service a central part of their lives."

Barb has shown her commitment to the food pantry during these last seven years. In fact, she often acts as a substitute to cover someone else's shift so that the pantry can remain open. 
TESTING PRIVATE WELL WATER...

Most of the unincorporated Cook County residents in Wheeling Township have private wells to provide their water service. A frequent question asked “is my well water safe to drink”? Properly constructed and maintained, private wells and water treatment systems can provide many years of trouble free service. However, well pumps and filters can deteriorate allowing surface

contaminants to enter the water. Groundwater may contain bacteria or chemical substances at levels above health standards. Contaminates can often not be detected by sight, taste or smell. Many of the most serious problems can only be detected through laboratory testing of the water. While public water systems are regularly tested for a variety of contaminants, private well water testing is the responsibility of the homeowner.

Coliform bacteria and nitrates are the most common well water contaminants and should be tested on a yearly basis. Certified labs test well water, such as McHenry Analytical Water Laboratory, Inc. They are willing to deliver water testing kits to the Wheeling Township Hall for resident pick-up and drop-off of water samples, 9:00 am – 1:00 pm, Monday through Thursday. The results are normally available within 24 hours after the samples are tested. Typical test costs are \$25.00 for bacteria and \$10.00 for nitrates. VEHICLE STICKERS FOR UNINCORPORATED COOK COUNTY

For residents of unincorporated Wheeling Township only – **don't get a ticket** – your new vehicle sticker should have been purchased by July 1, 2015! Cook County vehicle stickers are valid from July 1, 2015 to June 30, 2016. If you just moved into the unincorporated area or just bought a new vehicle, your fee is the normal rate. Proof of new residency or purchase of a car must be shown at the time you buy your sticker to receive the normal rate. If you forgot to purchase your 2015-2016 sticker, you will be charged a **late penalty** equal to the price of the sticker. However, if the police pull you over, you will receive a ticket and also have to pay for the sticker and an equal amount as a late penalty. Therefore, it is substantially less expensive to buy your vehicle sticker and pay a late penalty. Vehicle stickers are available for purchase at the Wheeling Township Clerk's Office Monday – Friday, between 9:00 a.m. – 4:30 p.m. The sticker fees are as the following rates: smaller passenger vehicles - \$80, larger passenger vehicles of at least 4500 pounds - \$100, physically handicapped vehicles – no fee, disabled veterans – no fee, senior citizen – no fee (two car maximum), motorcycles - \$25.

VOTER REGISTRATION

The primary elections for United States President, Senate, Congress, and many Illinois offices will be held on March 15, 2016 and the general elections for these offices on November 8, 2016. If you have just moved into the Township, have moved to another residence in the Township, or changed your name, you need to register to be able to vote in these future elections.

Avoid the election season rush and come to the Clerk's Office, Monday- Friday, between 9:00 a.m. – 4:30 p.m. and we will be pleased to register you to vote. All you need are two forms of identification (one showing your current address), be a citizen of the United States, be 18 years of age or older (you can be 17 years of age when registering as long as you are 18 years of age on election day), and live in the Township for at least 30 days before the election. For naturalized citizens, you must provide the date of your naturalization (the date is on your naturalization certificate).

Remember – once you have registered, you do not need to re-register unless you move or change your name.

2014 2ND INSTALLMENT PROPERTY TAX BILLS

By now you should have received the 2014 2nd Installment property tax bill. If you did not receive the tax bill, you can request a duplicate bill online at the Treasurer's website at www.cookcountytreasurer.com or by calling the Cook County Treasurer's office at 312-443-5100.

Property tax bills can be paid by mail, online or in person at any Chase Bank location or at the Cook County Treasurer's office in Chicago at the County Building at 118 N. Clark Street. To pay at a Chase Bank location, you will need an original or duplicate tax bill. You can pay online at the Treasurer's website www.cookcountytreasurer.com without a tax bill, but you will need your property index number and bank account and routing numbers. There is a small processing fee charged for this method of payment.

In reviewing your 2nd installment property tax bill, please note that any and all Homestead exemptions are permitted on one property only and that must be the owner's principal residence. Any exemptions taken on properties other than the owner's principal residence could be deemed “erroneous” and, therefore, subject to repayment with interest and possibly penalties.

2015 ASSESSMENT APPEALS

The Cook County Assessor scheduled the 2015 appeal period for Wheeling Township property owners for July and August of this year. The appeal period is open for approximately 30 days each year. Any 2015 appeal, if successful, will **affect 2015 2nd Installment property tax bills paid in July 2016**. During the 30-day window established by the Cook County Assessor, you can file an appeal online at www.cookcountyassessor.com or submit an appeal form. All appeals are filed with the Cook County Assessor, but we are available to assist you by providing information and direction on filing your appeal. Again, you will need the property index number (PIN) when you visit or call our office.

2015 is **not** a reassessment year for Wheeling Township. In 2016, the Cook County Assessor's office will mail new assessment notices to all property owners in Northern Cook County including Wheeling Township. There is no schedule for 2016 reassessments at this time. All assessments are published in the local newspaper in a triennial reassessment year. Only changes are published in the other two years.
