

New Service offered at the Township Center

ALZHEIMER'S CAREGIVER SUPPORT GROUP

It is estimated that as many as 5.1 million Americans may have Alzheimer's disease. The incidence of the disease is rising with the aging of America. Providing care for someone with memory loss can be a labor of love, but it can also be exhausting and stressful.



Wheeling Township has partnered with the Alzheimer's Association – Greater Illinois Chapter to offer a monthly support group for caregivers of individuals with Alzheimer's disease. The support group is designed to provide emotional, educational and social support for caregivers through monthly scheduled meetings.

Karen McNeir, R.N., B.S.N. and Kris Freeman, M.A. will be Co-Facilitators of this group, offering help to participants in developing coping methods and encouraging caregivers to maintain their personal, physical and emotional health, as well as providing optimal care for the person with dementia.

The Caregiver Support Group meets **the third Tuesday of every month at the Township Center from 1:00-2:30 pm.** Please contact Karen or Kris at to learn more about this service.

MEDICAL SERVICES

Wheeling Township recognizes the importance of older adults to remain living independently in their homes and their communities.

The following health services, administered by the Township nurse, are **available by appointment, for residents 60 years and over.**

Tuesdays & Thursday
9:00 a.m. – 1:00 p.m.

- Blood Pressure (no charge)
- Blood Sugar Screening (\$1 charge)
- INR & PRO Time – Anticoagulation Therapy Testing (\$6 charge)

Cholesterol Screening:

2nd & 4th Thursday of Each Month 9:00 a.m. – 11:30 a.m. (Available to residents 18 years & older)

Eight hour fasting (water only) lipid profile including total cholesterol, HDL, LDL, triglycerides and blood sugar (\$15.00 charge) Cholesterol screenings require drawing of a blood sample from the fingertip.

- At-home hemocult screening tests available for \$4.00



Concerned About the flu? What to do?

This year, the Township nurse will have a limited supply of the flu shots for homebound patients over the age of eighteen, who are unable to get a flu shot from their physician. Please call Karen McNeir, R.N., B.S.N. to schedule a home visit. The flu shot is covered by Medicare. If you do not have Medicare coverage, the cost is \$20.00

RING, RING! TEST THE AMPLIFIED PHONES!!



Do you have trouble hearing on the phone? Join Wheeling Township & Schaumburg Township Disability Services on Thursday, August 21 from 10 a.m. – 3 p.m. to test the ITAC fee amplified telephones and learn more about getting a free amplified phone. (Clients are also eligible for a new phone every four years.)

Participants must make appointments by calling 847-884-0030 in advance. Free amplified telephones are available to qualified Illinois residents with a hearing loss. **To qualify applicants must:**

- Be a legal resident of the State of Illinois
- Have telephone service at the address shown on your application form
- Have a licensed physician, speech pathologist, audiologist or designated DHS/DRS counselor sign the application form certifying the applicant is deaf, hard-of-hearing, Speech-Disabled or Deaf-Blind

Secretary of State RULES OF THE ROAD Review Course

The one-session Secretary of State Refresher Course will help prepare you for your driving test and soothe those road test jitters! This class is designed to give drivers, especially senior citizens and persons with disabilities, the knowledge and confidence needed to renew or obtain a driver's license. The review course, taught by knowledgeable volunteers, combines an explanation of the driving examination with a practice written examination.


AARP – SMART DRIVER COURSE

Tune Up Your Driving Skills...

In cooperation with AARP, Wheeling Township offers the AARP Smart Driver Course, designed to help you: **tune up** your driving skills, **learn** about normal age-related physical changes and how to adjust your driving to compensate and **reduce** your chances of receiving a traffic violation or getting into an accident. Call our office to register for one of the following two day sessions. A \$15.00 charge for AARP members and \$20.00 for non-members applies for the two session class. Checks should be made payable to AARP and mailed or dropped off at the Township Office prior to your first class. **Class time is 5:30 p.m. - 9:30 p.m. on the following dates:**

- Monday, August 4 & Wednesday, August 6
- Monday, September 8 & Wednesday, September 10
- Monday, October 6 & Wednesday, October 8
- Monday, November 3 & Wednesday, November 5

Upon the completion of the two-session class, you will be issued a certificate, which may be given to your auto insurance company for a possible discount.



TRANSPORTATION SERVICES

More Than Just a Ride!

Unable to drive? Looking for safe and affordable transportation?

If you are age 60 and over or age 18 and over with a permanent disability, the Wheeling Township Transportation services may be an answer for your transportation needs. Our service hours are 9:00 a.m. to 3:30 p.m. Monday through Friday within the Wheeling Township boundaries, with some exceptions for medical services. If you are in need of our transportation services, please call the Wheeling Township Transportation Department at (847) 259-7743 for program services and eligibility.



MOBILE DENTAL CLINIC



The Mobile Dental Clinic is a partnership with Northwest Community Hospital and Elk Grove, Palatine, Schaumburg and Wheeling Townships. It provides necessary dental care to residents who do not have resources to go to a general dentist. Residents must meet financial guidelines and there is a cost of \$30 per visit. Services are by appointment only. Call us to see if you qualify.

EMERGENCY ASSISTANCE

How Can We Help You?

Are you facing a difficult financial situation? Struggling to make ends meet? Wheeling Township General Assistance Office is here to help you.

The General Assistance staff can assess your situation and determine if you qualify for one of our many programs. We can also screen you for DHS programs such as SNAP (formerly Food Stamps) or Medicaid.

Emergency Assistance is a one time financial grant open to any resident facing a life-threatening circumstance, such as eviction or utility disconnection. Residents must complete an application, provide verifications and qualify based on financial and non-financial factors.



GIVE A GARDEN GIFT

Do you have a green thumb? Have you been nurturing your garden? As you take in those ripe tomatoes and other vegetables, please consider donating a portion of your harvest to the Wheeling Township Food Pantry. In conjunction with the Daily Herald, Wheeling Township participates in the **Giving Garden**, a program in which residents from our community share the fruits of their labor with others. Since most Food Pantry items are non-perishable, the fresh produce is a welcome addition and a healthier alternative for the families using the pantry.



Fresh veggies and fruits are received by Wheeling Township Monday through Thursday, from 9:00am until 4:30 pm. Items need not be washed; however, please remove all loose dirt and lingering insects prior to dropping off. Last summer, local gardeners generously donated their fresh produce in abundance. *We hope that your green thumbs will continue to work for us this year!*

Doris Rhodes – I love the new client choice style of the pantry. People like choosing their own food. There is less waste this way because families are receiving the items they like to eat.



For a family already struggling to pay rent and buy food each month, purchasing school supplies for several children adds an extra financial burden. You can help to alleviate that burden by picking up a few necessary items during your next trip to the store.

The General Assistance Department is accepting donations of new school supplies now through August 15th.

2013 2ND INSTALLMENT PROPERTY TAX BILLS

By now you should have received the 2013 2nd Installment property tax bill. If you did not receive the tax bill, you will need to contact the Cook County Treasurer at 312-443-5100 to request a duplicate bill. Please be patient and have your property index number (PIN) available. You can also visit the Treasurer's website at www.cook-countytreasurer.com for additional information.

Property tax bills can be paid by mail, online or in person at any Chase Bank location or at the Cook County Treasurer's office in Chicago at the County Building at 118 N. Clark Street. To pay at a Chase Bank location, you will need an original or duplicate tax bill. You can pay online at the Treasurer's website referenced above without a tax bill, but you will need your property index number. Check a previous bill for the property index number or search by address at www.cookcountypropertyinfo.com.

Please review your bill carefully, and contact us with any questions. Our phone number is 847-259-1515.

2014 ASSESSMENT APPEALS

The Cook County Assessor scheduled the 2014 appeal period for Wheeling Township property owners for July and August of this year. The appeal period is open for approximately 30 days each year. Any 2014 appeal, if successful, will **affect 2014 2nd Installment property tax bills paid in July 2015**. During the 30-day window established by the Cook County Assessor, you can file an appeal online at www.cookcountyassessor.com or submit an appeal form. Appeal forms are available at that same website or from our office or any Cook County Assessor's office. Appeals are reviewed and decisions made by the Cook County Assessor's office. We are available to assist you by providing information and direction on filing your appeal. Again, **you will need the property index number (PIN)** when you visit or call our office.

The Cook County Assessor permanently closed the Rolling Meadows branch office as of Friday, May 30, 2014. The Cook County Assessor still maintains branch offices at a number of suburban locations including Skokie. The Skokie office is located in the Cook County Circuit Courthouse located at 5600 Old Orchard Road, Room 149, Skokie, IL 60077. The phone number at that location is 847-470-7237.

VOTER REGISTRATION

The general elections for United States Senate, Congress, Illinois Governor, and most Illinois offices will be held on November 4, 2014. If you have just moved into the Township, have moved to another residence, or changed your name, you need to register to be able to vote in future elections. Avoid the election season rush, come to the Clerk's Office, Monday-Friday, between 9:00 a.m. – 4:30 p.m. to register. All you need are two forms of identification (one showing your current address), be a citizen of the United States, be 18 years of age or older by November 4, 2014 (you can be 17 years of age when registering as long as you are 18 years of age on election day), and live in the Township for at least 30 days before the election. For naturalized citizens, you must prove the date of your naturalization.

You may also register to vote at the Cook County Clerk's Office at 69 W. Washington Street, Room 500, Chicago, Illinois or at the Rolling Meadows Court House, Clerk's Office, located at the corner of Wilke and Euclid in Rolling Meadows.

Remember — Once you have registered, you do not need to re-register unless you move or change your name.

VEHICLE STICKERS FOR UNINCORPORATED COOK COUNTY

For residents of unincorporated Wheeling Township only – **don't get a ticket** – your new vehicle sticker should have been purchased by July 1st! Cook County vehicle stickers are valid from July 1 – June 30. If you just moved into the unincorporated area or just bought a new vehicle, your fee is the normal rate. Proof of new residency or car purchase must be shown at the time you buy your sticker to receive the normal rate. If you have an old sticker and forgot to purchase your 2013-2014 sticker, you will be charged a late penalty equal to the price of the sticker. However, that is cheaper than a ticket and also paying the penalty. Applications and stickers are available for purchase at the Wheeling Township Clerk's Office Monday – Friday, between 9:00 a.m. – 4:30 p.m.

Please understand that the Cook County Board determines the price of Cook County vehicle stickers and not the Township. The sticker fees are as the following rates: smaller passenger vehicles - \$80, larger passenger vehicles of at least 4500 pounds - \$100, physically handicapped vehicles – no fee, disabled veterans – no fee, senior citizen – no fee (two car maximum), motorcycles - \$25.

SENIOR CITIZEN RESIDENTS AND PERSONS WITH DISABILITIES OF UNINCORPORATED WHEELING TOWNSHIP — FREE NEW STICKER!

This year there are **FREE** new vehicle stickers for senior citizens (for those 65 years and older), for persons with disabilities, and disabled veterans. A letter from Cook County was sent to senior citizens, persons with disabilities, and disabled veterans who reside in unincorporated Wheeling Township explaining that permanent new vehicle stickers need to be picked up and displayed on vehicles by July 1st. Anyone who resides in unincorporated Wheeling Township and qualifies for this sticker should immediately display the new permanent vehicle sticker to avoid the \$25 fine.

WORKING WITH ARLINGTON HEIGHTS ON ROAD RESURFACING PROJECT...

Wheeling Township has been working diligently with the Village of Arlington Heights on resolving road resurfacing issues for our unincorporated areas that are long overdue for repairs. Although Betty Drive south of Dunlo Avenue is in severe need of repair and has not been resurfaced for many years, the authority to do this has been complicated by village and county jurisdiction problems. Many of the homes on the east side of the road have been annexed by the Village of Arlington Heights, making the road maintenance a joint jurisdiction between Arlington Heights and Wheeling Township Road District.



Last year, I worked with **Scott Shirley**, Director of Public Works for Arlington Heights to assist and coordinate a cost sharing resurfacing project for this portion of Betty Drive. In addition to this, we elected to pay for some road drainage improvements along the west side of the road. Both of these projects were included in the upcoming Arlington Heights annual road maintenance contract, and the work will be done under their supervision. Wheeling Township will be working on and overseeing the drainage improvements as well as the resurfacing work on Betty Drive.

I want to thank **Scott Shirley** and the **Village of Arlington Heights** for this agreement and the for their willingness to cooperate with the Township on these projects. Also, our thanks goes to **Nanci Julius**, the project coordinator from the Village of Arlington Heights Engineering Department, who worked with us to add the drainage improvements to their annual road maintenance bid package.
