



## A TRANSPARENT TOWNSHIP — THE YEAR IN REVIEW



Wheeling Township’s revenue is derived almost entirely from property tax dollars and amounts to less than 1% of the average homeowner’s tax bill. There are approximately 154,000 residents living in Wheeling Township.

Townships are mandated by state law to provide General Assistance, a local form of public aid, to those experienc-

ing financial crisis. We are also mandated to maintain our 5 miles of unincorporated roads, and offer help to citizens with property tax questions and appeals. We are the government closest to the people and our goals are to feed the hungry, assist those in financial crisis, provide transportation to the elderly and those with disabilities, fund needed social services – we are a safety net for those in need. A recent article in the Daily Herald highlighted funding provided by Wheeling Township to various local agencies that address issues with developmental and/or physical disabilities. A heartbreaking call from an ailing senior citizen worried about her disabled adult child after she is gone, confirms to us that our funding is crucial and necessary. *(See a list of funded agencies on page 8.)*

We have steadfastly reduced reserves and increased services while experiencing minimal or no increase in budgets. Our Food Pantry operates strictly with donated funds – no tax dollars are used. We owe this in part to a community of generous donors, appreciated and valued volunteers, partnerships and intergovernmental cooperatives that help make our work possible with the least impact to taxpayers. Wheeling Township is proud to say that we care for our community with low tax rates, balanced budgets, fiscal responsibility, and full transparency.

***Here is a recap of some of the services we provided in fiscal year 2017-18:***

- 25,325 dial-a-ride and medical van rides
- 13,179 meals delivered to homebound residents
- 5,343 visits to the Food Pantry – 11,912 people fed
- 837 LIHEAP applications processed
- 270 Thanksgiving Baskets distributed
- 238 families participated in the Adopt-a-Family program
- 121 Easter Baskets distributed
- 3,061 property tax exemptions processed
- 1,768 property tax appeals processed
- 1,373 nurse visits

# FROM THE ASSESSOR'S OFFICE

### 2017 2nd INSTALLMENT PROPERTY TAX BILLS

The treasurer normally mails the 2nd installment tax bills on or about July 1st, with a due date the first part of August. We recommend that you check the bill carefully. The bill should have a summary of the tax bill calculation and any relevant exemptions. If an exemption is missing from the bill, you will need to complete a **Certificate of Error form** - and submit it along with a copy of the current property tax bill and a copy of a valid driver's license, or Illinois ID card with the address of the property to the Cook County Assessor's office. If you were born in 1952 or earlier, you are entitled to a senior exemption, or possibly senior freeze exemption along with your homeowner exemption on your primary residence only. **All senior exemptions must be renewed every year.** If you have any questions, or need assistance filing for your exemption, please call us at 847-259-1515. **We ask that you have your tax bill with your property index number (PIN) available.** The PIN is found at the top of the property tax bill.

The Cook County Assessor maintains a branch office at the Skokie Circuit Courthouse building located at 5600 W. Old Orchard Rd., Room 149, Skokie, IL 60077. Their phone # is 847-470-7237. The Cook County office can issue a revised bill.

If you filed an appeal for your 2017 assessed value and received a reduction, it will be reflected on your 2nd installment tax bill. You will have another opportunity to file an appeal with the Cook County Assessor for next year's assessed value. We are tentatively set to open for appeals July 26, 2018. You can check the website [www.cookcountyassessor.com](http://www.cookcountyassessor.com) - under appeals for dates and deadlines.

We are available to assist you by providing information and direction on filing your appeal. Contact us by email at [taxpayerrassistance@wheelingtowship.com](mailto:taxpayerrassistance@wheelingtowship.com) - after June 1st, and provide your property index number for possible comparables for an appeal. If you do not use the internet you may contact us by phone at 847-259-1515, or by visiting our office. We ask that you have your property index number available when calling or coming in to the office, so we can assist you in a timely manner.

## TOWNSHIP ROAD MANAGEMENT

Since January 1, 2017, the maintenance of approximately five miles of unincorporated roads within Wheeling Township is the responsibility of the Township Board of Trustees. Township staff, under the direction of the Board, outsources for all needed services. We also have oversight duties over new construction designs on properties within our jurisdiction to ensure that their property storm water drainage will not adversely affect their neighbors or adjacent municipalities.



### Our project plans for 2018 include:

- Road resurfacing along Morrison Avenue from River Road to Lee Street
- Drainage improvements at the intersection of Morrison Avenue and Lee Street

- Crack-sealing along Lee Street
- Continue encouraging Cook County and Homeland Security to purchase and demolish six flood-prone homes in the unincorporated Forest River subdivision
- Annual spring pothole patching throughout the unincorporated areas.
- We may consider other projects as the availability of our budget permits.

## VOTER REGISTRATION and VEHICLE STICKERS:

### VOTER REGISTRATION

The General Election for Governor and other State and Federal offices on November 6, 2018 promises a large voter turnout. If you want to vote in the General Election, now is time to make sure you are registered. If you are not registered, have just moved into the Township, have moved to another residence in the Township, or changed your name, you need to register to be able to vote in future elections. To register, come to the Clerk's Office, Monday-Friday, between 9:00-4:30. All you need are two forms of identification (one showing your current address), be a citizen of the United States, be 18 years of age or older by the November 6, 2018 election, and live in the Township for at least 30 days before the election. If you are 17 years of age but will be 18 years old on November 6, you can register. For naturalized citizens, you must prove the date of your naturalization. If you have an Illinois driver's license or state ID, you may register online through the Illinois State Board of Elections website [elections.il.gov](http://elections.il.gov). If you don't have a driver's license or state ID, go to [cookcountyclerk.com](http://cookcountyclerk.com) and complete the form online, print, sign and mail it to the address on the application. If you register by mail, you must bring a valid state-issued picture identification when you vote for the first time. Finally, you can always register by visiting the Cook County Clerk's Office at 69 W. Washington Street, Room 500, Chicago, or the Rolling Meadows Court House, Clerk's Office, located at the corner of Wilke and Euclid in Rolling Meadows.

*Remember - Once you have registered, you do not need to re-register unless you move or change your name.*

### VEHICLE STICKERS:

For those living in unincorporated Wheeling Township only – don't get a ticket, buy a vehicle sticker. These Cook County Vehicle Stickers for the unincorporated areas of

Wheeling Township will be available for purchase at the Township Clerk's Office. Stickers are valid from July 1, 2018 until June 30, 2019. The cost for stickers varies, but generally an automobile is \$80, a small truck is \$100 and a motorcycle is \$25. Senior citizens (65 years and older) can receive up to two stickers free of charge.



Others eligible for no fee stickers are individuals with physical disabilities and disabled veterans. If you have purchased a vehicle within the last 30 days or moved to an unincorporated area within the last 60 days - you will not be charged a late fee.

### Prorated Vehicle License

A resident of unincorporated Wheeling Township qualifies for a prorated vehicle sticker, per ordinance, if they purchase a new vehicle on or after Dec 1st through June 30th and purchase a vehicle sticker within 30 days of the new vehicle purchase. The following is required:

1. Resident must provide their Bill of Sale or registration which includes the vehicle and residents information
2. Resident must provide their valid driver's license, state ID or equivalent identification card

If a resident purchases a new vehicle on or after December 1st through June 30th but fails to purchase their vehicle sticker within the 30 day grace period, the resident would be liable for the regular fee. **\*New Cook County residents do not qualify for the prorated fee.**

Please be aware that the Cook County Sheriff's Police will ticket vehicles registered in unincorporated Cook County that do not display a current sticker. In addition to the ticket, you will need to purchase a vehicle sticker with a late penalty. Therefore, please purchase your sticker by July 1. When you come to purchase vehicle stickers, please bring a check or money order, we cannot accept cash or credit cards.

**Do you have old or unused prescription medications that you no longer need?** Consumers and caregivers should remove expired, unwanted, or unused medicines from their home as quickly as possible to help reduce the chance that others may accidentally take or intentionally misuse the unneeded medicine.

It is important to dispose of unused medications properly to help reduce harm from accidental exposure or intentional misuse. There are many locations in Wheeling Township that you can safely dispose of medications:


If you don't want to tackle a garden by yourself, consider helping at a community garden or talk to your neighbors and cooperate by having

- **Cholesterol Screening** (\$15 charge) Available to residents 18 years & older. Test provides a lipid profile including total cholesterol, HDL, LDL, triglycerides and blood sugar.

*Patient needs to fast 10 – 12 hours; but remember to please drink plenty of water (but no coffee/tea/soda/juice, etc).*

## 31ST ANNUAL COMMUNITY PAINT-A-THON

**September 15**



Wheeling Township is one of 10 area townships participating in this year’s Paint-A-Thon. Who qualifies? Older (60+) or disabled homeowners of single-family residences who are financially disadvantaged and who are physically unable to paint their homes themselves are eligible to get the exterior of their home painted as part of this year’s Paint-A-Thon. The homes must be owner-occupied and in sufficient condition so that scraping and spot priming are the only preparations needed. Rain date is 9/22.

Paint-A-Thon is a major volunteer event. Teams of volunteers are recruited from businesses, churches, social service and civic groups. Volunteers must be at least 14.
